

PRIVACY STATEMENT IN ACCORDANCE WITH ART. 13 AND 14 EU REG. NO. 679 OF 2016 FOR WEBSITE USERS

The main aim of Lumson S.p.A. (hereinafter also referred to as "**Lumson**", the "**Company**", "**we**" or "**us**"), in our capacity as Data controller (the "**Controller**"), is to meet all applicable legal requirements relating to personal data protection and, for this reason, ensure we fulfil all obligations for full compliance with the relevant regulation in force. In compliance with EU Regulation 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, we would like to provide users of our site ("**you**" or "**your**"), as the data subject (hereinafter, the "**Data Subject**"), with information on the processing of personal data (hereinafter, the "**Data**"), which you supply to us during the course of your visit to the website, as well as on your rights.

The Data Controller

Data processed by Lumson

The following types of Data are processed here at Lumson:

- data supplied by you of your own accord as you interact with the site's functionalities and request services offered by the site, such as, by way of example, data supplied when you sign up to the site, access the restricted area, or submit a query or a request for informational material to Lumson.
- identification data implicit in the use of internet communication protocols (so-called "browsing data"), which are acquired by computer systems and software routines that enable users to browse the website.

Purpose of data processing

Lumson shall process your Data for the following purposes:

- i. browsing data are collected and processed by Lumson only for statistical purposes and in anonymous form relating to access and use of the site, for the purpose of monitoring and improving the functionality and content of the site in question;
- ii. to enable Lumson to deliver the services you have requested where you have voluntarily signed up to the site to take advantage of said services;
- iii. to update you on products, offers, exclusive deals, promotional campaigns, events and similar initiatives organized by Lumson, or in which Lumson takes part, including invitations, if any, to said events where you have given your explicit consent.

Said communications will be delivered through various channels set up by Lumson, such as email (in which case, the communication may entail the transfer of Data to non-EU countries, which will be carried out taking appropriate measures to ensure Data are protected).

Remember that you can withdraw your consent freely and at no charge, at any time, by contacting us at the above-mentioned addresses.

In addition, the Data mentioned under point **(ii)** must be supplied if Lumson is to provide the services requested. Consequently, failure to supply the Data may mean you will not be able to utilize the services offered by Lumson.

With reference to the purposes mentioned under point **(iii)**, on the other hand, the supply of Data is voluntary and will not impact your browsing experience or stop you from utilizing the services offered by Lumson.

Sharing of Data

Your Data will be shared with the following categories of recipients, as part of processing for the above-mentioned purposes:

- data processors as identified each time;
- third parties, which can include international third parties, providing Lumson with services;
- companies and professionals whose services the Controller employs to protect its rights (for example, accountants, lawyers, tax consultants, auditors, advisors, etc.).

Data retention period

Your Data will be kept for no longer than is necessary for the purposes mentioned above and, beyond said period:

- no longer than the applicable limitation period. Should the limitation period be interrupted, the retention period shall be extended accordingly;
- within the limits prescribed by the rules on Data retention, to comply with any legal obligations;
- for the period required to protect Lumson's rights in the event of any legal disputes.

Your rights

The data protection regulation (GDPR) provides a series of rights for the entire duration of processing. The rights you are entitled to, as the data subject, are as follows

- **right to access:** you are entitled to know what data are being processed and all information regarding processing.
 - **right to rectification:** you are entitled to request that incorrect or obsolete data be edited.
 - **right to portability:** you are entitled to get a copy of the data being processed, in a structured, commonly used and machine-readable format, in order to enable said data to be transferred to another data controller, other than Lumson.
 - **right to restriction of processing:** you are entitled to restrict the processing of your data, provided one of the circumstances set out in the regulation applies.
 - **right to erasure:** to request data to be erased.
 - **right to object:** to request that data processing be stopped (e.g. stop commercial communications).
 - **right to lodge a complaint with the supervisory authority:** you are entitled to submit feedback, claims or complaints to the competent supervisory authority ("Garante", the Italian information commissioner's office).
- iv.** You can exercise said rights in a variety of ways: by post, email or any other communication tool you choose, using the above-mentioned addresses and submitting the request with the documents attached required to identify you as the legitimate data subject (e.g. a copy of your passport or other ID).
